



## Spectrum Brands Holdings Announces Voluntary \$50 Million Prepayment on Term Loan

### Company Achieves \$220 Million of Term Loan Prepayments in Fiscal 2011

MADISON, Wis., Sep 26, 2011 (BUSINESS WIRE) --

Spectrum Brands Holdings, Inc. (NYSE: SPB), a global consumer products company with market-leading brands, today announced a voluntary prepayment of \$50 million to reduce its Senior Secured Term Loan to \$525 million at fiscal 2011 year-end on September 30, 2011.

The Company has made a total of \$220 million of voluntary prepayments on its original Term Loan of \$750 million in fiscal 2011, including this latest \$50 million prepayment and previous prepayments of \$50 million in November 2010, \$20 million in December 2010, \$20 million in May 2011, \$40 million in July 2011, and \$40 million in August 2011. Scheduled amortization accounts for an additional \$5 million reduction.

"The top priority use of our free cash flow is to rapidly pay down debt, significantly strengthen our balance sheet, and reach a target leverage ratio of 3.5 times or less by the end of fiscal 2011," said Dave Lumley, Chief Executive Officer of Spectrum Brands Holdings. "We remain focused on growing our EBITDA and generating strong free cash flow to create significant shareholder value."
