



Spectrum Brands Holdings' Hardware and Home Improvement (HHI) Group Completes Acquisition of Tell Manufacturing, Leading U.S. Provider of Commercial Doors, Locks and Hardware

MIDDLETON, Wis.--(BUSINESS WIRE)--Oct. 2, 2014-- Spectrum Brands Holdings, Inc. (NYSE: SPB), a global and diversified consumer products company with market-leading brands, announced today its Hardware and Home Improvement Group (HHI) has completed the acquisition of privately owned Tell Manufacturing, Inc., a leading U.S. manufacturer and distributor of commercial doors, locks and hardware with annual revenues of nearly \$40 million. Financial terms of the accretive, all-cash transaction were not disclosed. A definitive agreement to purchase Tell was announced on September 18.

"Tell accelerates HHI's entry into the large and attractive \$3 billion U.S. commercial door hardware and lock market," said Dave Lumley, Chief Executive Officer of Spectrum Brands. "Among the many benefits Tell brings to HHI are a strong commercial security sales position, a leading share in the growing U.S. modular building industry, new non-retail channels, mutual cross-selling opportunities in multiple channels, and hollow metal door manufacturing expertise."
