## Item 5.07. Submission of Matters to a Vote of Security Holders.

Spectrum Brands Holdings, Inc. (the "<u>Company</u>") held its 2020 Annual Meeting of Stockholders (the "<u>Annual Meeting</u>") on July 28, 2020. A total of 40,878,962 shares of the Company's common stock, par value \$0.01 per share (the "<u>Common Stock</u>"), were present in person or represented by proxy at the Annual Meeting, representing 94.94% of the Company's outstanding Common Stock as of June 3, 2020, the record date.

The Company is pleased to have had a significant percentage of its outstanding shares of Common Stock participate in the Annual Meeting and vote in favor of each proposal presented for consideration. The final results for the votes regarding each proposal are set forth below, including the approval percentage for each proposal, represented as a percentage of total votes cast for each such proposal:

<u>Proposal 1</u>. The Company's stockholders elected each of the following persons as Class II directors of the Company for a term of three years and until his successor is elected and qualified. The votes regarding this proposal were as follows:
